<u>DISTINGUISHING FEATURES OF THE CLASS</u>: An employee in this class is responsible for coordinating and directing the activities of the Women, Infants and Children Program for the Ulster County Department of Health. Direct supervision is received from the Director of Patient Services although leeway is allowed in carrying out the details of the work. Supervision is exercised over all subordinate personnel assigned to the WIC Program. Does related work as required.

TYPICAL WORK ACTIVITIES: The typical work activities listed below, while providing representative examples of the variety of work assignments in the title, do not describe any individual position. Incumbents in this title may perform some or all of the following, as well as other related activities not described.

Responsible for managing all clinical program aspects of the WIC Program;

Responsible for complying with Federal and State reporting requirements related to the program;

Responsible for budget management of the program;

Develops and implements procedures for nutrition education, certification and recertification, data collection and documentation in accordance with Federal and State regulations;

Develops and implements program outreach activities;

Oversees recruitment, orientation, supervision and evaluation of program staff;

Compiles information and statistics necessary for continued program funding:

Conducts and arranges for in service education.
