## SUPERVISING PUBLIC HEALTH NURSE

**DISTINGUISHING FEATURES OF THE CLASS**: This is a professional nursing position, under the supervision of the Director of Patient Services. It involves the responsibility for the provision of nursing services and the supervision of nursing practice to assure safe, effective and efficient comprehensive nursing care in homes, clinics, schools and other community facilities. Supervision of the work of assigned public health professionals or auxiliary nursing staff is required. Does related work as required.

**TYPICAL WORK ACTIVITIES**: The typical work activities listed below, while providing representative examples of the variety of work assignments in the title, do not describe any individual position. Incumbents in this title may perform some or all of the following, as well as other related activities not described.

Assists in planning, implementing, coordinating and evaluating the nursing program within the agency;

Supervises nursing practice to ensure a high quality of professional service and maintenance of agency standards;

Assists in planning and conducting educational programs for nursing staff;

Assists in maintaining the proper utilization of the services of the nursing staff;

Participates in surveys, studies, and research in the field of public health;

Assists faculty with the implementation of student programs;

Reviews and compiles appropriate records and reports;

May act as the Coordinator of the Long Term Home Health Care Program;

May coordinate contact tracing and case investigation.
